

**Privacy Policy**

Car2Go car sharing T.L.V (hereinafter: “the Company”) intends to clarify in this document, to the extent that is possible, their policy regarding user privacy on the websites that the Company manages and operates (hereinafter, for the sake of convenience, the websites will be referred to as “the company’s sites” or “the sites”).

In addition, all indication in this document to Subscriber refers to both members and/or drivers.

Collection and Receipt of Information by the Company’s Sites

The details provided by the customer during registration on the website and/or over the phone via the company’s customer service center and/or in the system and/or on the company’s landing page, all or in part, will be preserved in the company’s databases.

The company reserves the right to collect information regarding subscribers’ purchasing habits while the subscriber is on their site as well as information about the services that he or she has purchased, services in which he or she expressed interest, pages that he or she visited, offers that interested the subscriber and any other information and may make use of cookies to collect such information.

The information in this section will serve the company during the subscriber’s future visits to the site and will allow the company to offer the subscriber targeted offers and deals.

The company is entitled to use the personal details that the subscriber provided when placing the reservation and all the information collected on the subscriber when he or she uses the site and/or system for the extraction and analysis of statistical information.

The company is entitled to transfer the statistical and other data to third parties, as long as the data does not relate to a specific subscriber personally or allow for his or her identification.

The site user is under no legal obligation to provide the information listed above, however provision of information to the company and/or authorization of this contract serves as consent on the part of the subscriber to the serves as consent by the subscriber for all uses set forth in this contract in connection with the information including the transfer of the information to third parties in accordance with the provisions of this contract.

Transfer of Information to a Third Party

The company and vehicle rental service will not transfer identifying information of the subscriber to a third party, including to a credit card company or to any judicial forum except under the following circumstances:

1. There exists a legal requirement to transfer the information
2. For the purpose of collecting payments owed to the company by the subscriber in connection with this contract.
3. In the event that the subscriber violated the conditions of the contract or any additional agreement with the company and/or its representatives.

4. In any dispute, claim, request, or legal proceedings, if such exist, between the subscriber and the company.
5. In the event that the subscriber performed an act or made an omission that has harmed or may harm the company or any third party, including the company's customers and/or subscribers.

Third Party Services

Certain services on the company's sites, such as services related to Facebook, are managed by parties other than the company. In such cases, the services are provided or offered not solely through the company's computers, but rather through other parties, as mentioned.

Information Security

The company does the utmost, using available methods, to maintain the confidentiality of information and secure the information collected on the websites and in the system. That said, since it is an online environment, the company cannot absolutely guarantee prevention of computer intrusions or exposure of the information stored within. In the event that the information falls into the hands of a third party that has penetrated into the saved information or misuses the information, the site user declares that he or she will have no claim, demand, and/or request from the company and/or its designees.

It is further clarified the privacy policy in no way expands the obligation by the company/car rental service that exists under the law.

Changes to the Privacy Policy

The company and its sites are entitled to change the privacy policy from time to time. Any significant change to the provisions related to the use of the personal information that you provided will be accompanied by an appropriate notice on the company's site.
